- 1. The Parties will process the name, address, e-mail address and telephone number of the contact person solely for the purpose of maintaining contact in connection with the performance of the Contract, and for taking the steps necessary for the performance or conclusion of the Contract.
- 2. In the legal relationship between the notifying Party and its contact person, the notifying Party is obliged to provide the appropriate legal basis for the provision of data to each other. By signing this declaration, the notifying Party declares that it has the appropriate legal basis for the transfer of the data.
- 3. The Parties have a legitimate economic interest in processing the data, which is evident in the fact that it is essential for the contractual performance of the Contract that the Parties are able to maintain contact with each other and to consult as necessary in connection with the performance of the Contract.
- 4. The duration of processing the data is 3 years from the day the contact person's right to act in this capacity ceases but at most 3 years from the termination of contract.
- 5. The contact person may object to his or her data being processed or may request their erasure, restriction (blocking) or rectification.
- 6. In view of the contents of point 2, the contact person should submit any requests in accordance with point 5 to the notifying Party. The notifying Party is obliged to notify the other Party without delay if, in consequence of its contact person's request made in accordance with point 5, there is a change in the data of the contact person or the data may not be processed in the future. If the notifying Party requests its contact person's data to be deleted, at the same time it is obliged to appoint a new contact person and provide the other Party with the new contact person's data.
- 7. If the contact person of one Party indicates an objection to the deletion, restriction (blocking) or rectification of the data to the contact person of the other Party or to the customer service of the other Party using its contact details (for the User:; for Magyar Posta: Magyar Posta Zrt. 1540 Budapest, 06-1-767-8282, uzleti.ugyfelszolgalat@posta.hu), the given Party must notify the other Party of the request with regard to the provisions of point 2.
- 8. In response to a request made by the contact person to receive information about the processing of his or her data, the Party receiving the submitted request will make available, in writing if so requested, the processed data and provide all requested information in relation to data processing to the contact person submitting the request. The contact person can submit his or her request to the other Party's contact person or customer service (at the contact details specified in point 7), giving his or her identification data (name, e-mail address, telephone number) and the contract number. Requests submitted will be executed by the Party concerned without delay but at the latest within 1 month of the date of submission of the request.
