**OTHER FEES RELATED TO POSTAL SERVICES (HUF)**

## 1. Postage due fees for letter mail

- 1) The fee for the service is tax exempt.
- 2) For domestic non-priority non-registered letters (postcards, picture postcards) with insufficient postage paid, a postage due fee equivalent to the unpaid fee must be paid in addition to the unpaid fee.
- 3) With postage due fees that end in a figure other than 5 or 0, Magyar Posta applies the rules of rounding.

### 1/A. Fees payable for correcting deficiencies in preparing postal parcels for posting

1) If a sender with a separate written contract does not meet, or does not meet satisfactorily, the conditions for preparing mail items for posting, and in particular the requirements laid down in point 3 of the **GENERAL TERMS AND CONDITIONS FOR POSTAL SERVICES** and in the separate written contract with regard to the contents, packaging, sealing and addressing of mail items as well as the use of receptacles and the placement of mail items in them, or if a difference or irregularity is found between the data featured in the electronic posting list and the data of the mail items actually handed over for posting (e.g. wrong pricing), Magyar Posta will charge the separate fee laid down in paragraph 2) for the difference or irregularity.

- 2) The fee for the service is subject to 27% VAT.

## 2. Individual fees to be paid for return delivery and fees to be reimbursed

1) The VAT category of the fee for the service is the same as that of the postal service related to the mail item to be returned.

2) Magyar Posta will endeavour the return delivery to the sender of mail items that cannot be delivered to the addressee or other authorised recipient in accordance with the provisions of Point 6.12 of the **GENERAL TERMS AND CONDITIONS FOR POSTAL SERVICES** without charging an extra fee with the exception of the provisions of paragraphs 6) to 10).

3) If Magyar Posta charges for the return delivery, it will deduct the fee – with the exception of the disparate provisions included in paragraph 3/A) – for the return delivery from the fee already paid for services and additional and supplementary services which were not performed, and the remainder of the fee for the unperformed services and additional and supplementary services will be refunded to the sender. If the return delivery fee is not more than the fee for the unperformed services and additional and supplementary services, the difference must be paid by the sender upon return delivery.

3/A) If Magyar Posta charges a fee for the return delivery of an MPL Postal Parcel or MPL Business Parcel, the fee is to be paid upon the return delivery – prior to the acceptance of the

parcel – by the authorised recipient. After the return delivery fee has been fully paid, based on the sender's specific request made at the time of the return delivery, Magyar Posta will subsequently reimburse to the sender any previously paid amounts for additional and supplementary services which have not been provided.

6) For the return delivery of MPL postal parcels the fee payable is HUF 1,140.

7) The return delivery fee of MPL Business parcel used without signing a written contract is HUF 898 + VAT (HUF 1,140 gross). For the return delivery of postal parcels posted with the addressee pays additional service, the fee for the unperformed services is deducted from the aggregate sum of the fee payable by the addressee and the return delivery fee, with the exception of the addressee pays additional service fee.

When returning a Európa+ parcel posted with the Inverz service and an Inverz MPL Europe Standard parcel from the International Office of Exchange, the fee for an MPL Business parcel of the same weight and delivered to the door will be charged.

9) Further additional and supplementary services for both domestic and international destinations may be used for items posted in the prepaid envelopes and for the prepaid postcards described in paragraphs 3) to 6) by paying additional postage, and such items may also be posted as priority if the prepaid envelope does not contain this service already.

10) For priority letter-mail items prepared for posting using the non-priority prepaid envelopes and prepaid postcards described in paragraphs 3) to 5), the difference in the fee between the non-priority and priority postal service

a) for the 50 g letter for ordinary size envelopes;

b) according to the checked weight of letter-mail items for medium size envelopes will be charged during posting.

11) Provisions for the options of using domestic and international stamps without value indication described in paragraphs 7) and 8) are given in point 12.

12) Letter-mail items with dutiable content intended to be posted in international mail may not be dispatched in prepaid envelopes and by paying for postage with a postage stamp with no value indication or marking.

- b) For senders without a written contract for the use of the postal service, the mail items are to be placed in separate receptacles for each fee factor.
- c) The mail items may be posted at the postal service outlets listed in the document POSTAL SERVICE OUTLETS on the web page GTC for POSTAL SERVICES and at the ACCEPTANCE POINTS AT OPERATIONAL UNITS (of those listed only in the National Logistics Centre, Logistics Units and the Post Office in the Pest Letter Centre).
- d) If the sender, by applying the provisions of paragraph 14) of point 3.5 of the GTC FOR POSTAL SERVICES published on Magyar Posta's website, uses a list (list of addresses) to address mail items, the place of acceptance of such mail items will be that postal service outlet or Acceptance Point at an Operational Unit where the mail items enter postal network irrespective of the fact whether or not the list containing the addresses (list of addresses) is available to Magyar Posta at the time of the handover of the mail items or not.
- e) The sender must indicate the number of the inspection permit on both the electronic and paper-based posting lists. Magyar Posta provides posting with the fee for items suitable for automated processing provided the electronic posting lists include the

- 3) Non-registered priority and non-priority letters satisfy the conditions for a discount on fees if
- the sender has signed a written contract to this end with Magyar Posta,
  - the sender does not request an additional service;
  - the quantity of mail items within the same weight category posted at the same time exceeds 10,000 items,
  - the mail items are suitable for automated processing in accordance with the condition stated in paragraph 6) of point 10 and have an inspection permit,
  - the sender uses the special electronic posting list specified by Magyar Posta to dispatch the mail items, whose technical specifications are provided by Magyar Posta according to the date and the way agreed on with the sender, before the beginning date stated in the separate agreement,
  - only details of mail items posted with the regional tariff feature on the special electronic posting list,
  - the number of mail items posted are given for each postcode on the posting list; the zone classification for postcodes is available on Magyar Posta's web site at [www.posta.hu/level/vallalkozasoknak/tomeges\\_feladas](http://www.posta.hu/level/vallalkozasoknak/tomeges_feladas)
  - the mail items are physically separated into two groups based on their addresses, one into mail items listed according to zones and the other into mail items which are not listed according to zones, and their handover occurs using this separation upon pick-up/dispatch,
  - the sender posts the mail items only at the National Logistics Centre.

4) When establishing the amount accepted, the quantities of priority and non-priority mail items arriving with one pick-up (for dispatch at one time, on one or more posting list(s) appearing on

the same customer code) which belong to the same weight category but are sorted into different zones based on their address can be combined.

The quantities of mail items not sorted into zones based on their address can be combined with quantities of mail items sorted into zones, and such mail items will be accepted for postal handling and invoiced at the unit price for zone 4.
