

## **Other fees related to postal services (HUF)**

### **1. Postage due fees for letter mail**

- 1) The fee for the service is tax exempt.
- 2) For domestic non-priority non-registered letters, postcards and pictures postcards with insufficient postage paid, a postage due fee equivalent to the unpaid fee must be paid in addition to the unpaid fee.
- 3) With postage due fees that end in a figure other than 5 or 0, Magyar Posta applies the rules of rounding.

### **2. Individual fees to be paid for redirection or return delivery and fees to be reimbursed**

1) The VAT category of the fee for the service is the same as that of the postal service related to the mail item to be redirected or returned.

2) Magyar Posta will endeavour the return delivery to the sender of mail items that cannot be delivered to the addressee or other authorised recipient in accordance with the provisions of Point 6.12 of the General Terms and Conditions for Postal Services without charging an extra fee with the exception of the provisions of paragraphs 5) to 9).

3) If Magyar Posta charges for the return delivery, it will deduct the fee – with the exception of the disparate provisions included in paragraph 3/A) – for the return delivery from the fee already paid for services and additional and supplementary services which were not performed, and the remainder of the fee for the unperformed services and additional and supplementary services will be refunded to the sender. If the return delivery fee is not more than the fee for the unperformed services and additional and supplementary services, the difference must be paid by the sender upon return delivery.

3/A) If Magyar Posta charges a fee for the return delivery of MPL Postal, MPL Business, MPL Net parcels, the fee is to be paid upon the return delivery – prior to the acceptance of the parcel – by the authorised recipient. In the case of previously paid amounts for unfulfilled/additional and supplementary services, Magyar Posta will reimburse the fees to the sender.

4) If, under the Delivery after Payment letter (hereinafter: DAP) service, a delivery after payment form has been used, the fee for the unperformed services will be reimbursed in the manner below provided that the DAP item was returned to the sender for a reason not attributable to Magyar Posta or the sender requested the return of the item: HUF 750 + VAT up to an amount to be collected under the delivery after payment service of HUF 20,000; HUF 1,300 + VAT up to an amount to be collected under the delivery after payment service of HUF 50,000, and HUF 1,760 + VAT up to an amount to be collected under the delivery after payment service of HUF 100,000.

5) For redirecting letters postcards and picture postcards posted with the insured additional service, the addressee must pay an amount equivalent to the fee for the insured additional service upon acceptance as an ad hoc fee. For letters postcards and picture postcards posted with the insured additional service, the return delivery fee consists of the weight fee, the fee for the registered additional service and the fee for the insured additional service. This fee will be charged upon return delivery, which the sender must pay when receiving the returned item.

6) For the return delivery of MPL postal parcels the fee payable is HUF 970.

7) The return delivery fee of MPL Business parcel and MPL Net parcel used without signing a written contract is HUF 764 + VAT (HUF 970 gross). For the return delivery of postal parcels posted with the addressee pays additional service, the fee for the unperformed services is deducted from the aggregate sum of the fee payable by the addressee and the return delivery fee, with the exception of the addressee pays additional service fee.

8) If an international postal parcel or international priority postal parcel is redirected within Hungary, an amount equivalent to the fee for a domestic MPL postal parcel of the same weight is charged. When using the insured additional service, the fee for redirecting will be supplemented by an amount equivalent to the fee for the domestic insured additional service.

9) When an international postal parcel or international priority postal parcel is returned, both the fee determined by the foreign postal operator participating with Magyar Posta and the fee for an MPL postal parcel of the same weight are charged.

### **3. Individual fees to be paid for redirecting or returning Európa+ and MPL Europe standard parcels**

1) The fee for the service is subject to 27% VAT.

2) If a Európa+ parcel or MPL Europe standard parcel is redirected within Hungary, an amount equivalent to the fee for an MPL Business parcel of the same weight posted to the door is charged. For Európa+ parcel and MPL Europe standard parcel the return delivery is free. When a Európa+ parcel and Inverz MPL Europe standard parcel posted with the Inverz (return) service is returned from the International Office of Exchange, the fee for an MPL Business parcel of the same weight posted and delivery to the door is charged.

### **4. Sender's subsequent directions**

1) The sender of a mail item may give a subsequent instruction to change the address details of the mail item, and (with the exception of delivery after payment letter, letters delivered to the addressee only and e-notification) may request additional and supplementary services or priority, and may make amendments to or cancel ordered services, or request the return of the mail item.

2) The fee for the service is subject to 27% VAT.

## 10. Domestic letter mail in bulk

1) The service is VAT exempt.

2) Dispatch quantity

The minimum amount for dispatch is 201 mail items.

3) When determining the dispatch amount

- a) the amounts of letters, postcards and picture postcards in the same weight category can be grouped together,
- b) registered mail items posted with different additional and supplementary services may be combined within the same weight category,

- c) the quantities of non-registered and registered mail may not be combined.
- 4) For each dispatch
- a) for senders without a written contract for postal services: the number of mail items posted by one sender on one posting list,
  - b) for senders with a written contract for postal services:
    - 1.the number of mail items posted by one sender on one posting list,
    - 2.the number of mail items on one or more posting lists posted in the National Logistics Centre at one time by a sender with the same customer code<sup>1</sup>.
- 5) Suitability for automated processing
- a) The sender must send a sample of 10 items (a minimum of 50 if the number of items to be dispatched is over 100,000) from the minimum of 2,001 mail items suitable for automated processing in advance to the Inspection Unit (postal address: 1000 Budapest) for inspection purposes. The minimum amount is to be interpreted for each weight category for registered and non-registered items.
  - b) The sender may initiate the inspection of the samples at the Inspection Unit by completing the form "Order for the inspection of the suitability of barcode postal identifiers and of mail items for automated processing". The form is available from the postal contact person or the Inspection Unit, or may be downloaded from the web page [http://www.posta.hu/ugyfelszolgalat/nyomtatvanyok\\_urlapok](http://www.posta.hu/ugyfelszolgalat/nyomtatvanyok_urlapok). Inspection may only be requested by the sender or producer of the mail items.
  - c) The mail items sent for inspection must be of the same format (sealing, address, envelope profile, its material, postage paid indication, etc.) as the mail items intended for posting.
  - d) A report is made of the inspection, which certifies the suitability of the mail items for automated processing. The Inspection Unit forwards the original copy of the report and one sample of each mail item certified by a stamp to the person and acceptance point(s) indicated on the form.
  - e) The sender must indicate the number of the report on the posting list. The number of the report does not have to be included in an electronic posting list but the sender must give a copy of the report to Magyar Posta when posting the mail items.
  - f) The Inspection Unit inspects the sample mail items within 3 working days of their receipt at the latest.
  - g) The criteria for automated processing can be found on the page correct addressing. Magyar Posta may change the conditions published on the website unilaterally. Any change will be published on the website 30 days in advance.
- 6) Other conditions
- a) If the mail items comply with the conditions defined above, but they are not suitable for automated processing, the service may be used for the fee set for standard items.

<sup>1</sup> Customer code: The customer code is an 8-digit number which identifies contractual clients (customers) in Magyar Posta's SAP system who give or receive an independent invoice as a supplier or customer.

- b) For senders without a written contract for the use of the postal service, the mail items are to be placed in separate receptacles for each fee factor.
- c) The mail items may be posted at the postal service outlets listed in the document "Postal Service Outlets" on the web page [www.posta.hu/ugyfelszolgalat/aszf/postai\\_aszf](http://www.posta.hu/ugyfelszolgalat/aszf/postai_aszf) and at the Acceptance Points at Operational Units (of those listed only in the National Logistics Centre, Logistics Units and the Post Office in the Pest Letter Centre).

## 11. Regional tariffs

- 1) The service is VAT exempt.
- 2) Non-registered letters and priority letters satisfy the conditions for a discount on fees if
  - a) the sender has signed a written contract to this end with Magyar Posta,
  - b) the quantity of mail items within the same weight category posted at the same time exceeds 10,000 items,
  - c) the mail items are suitable for automated processing and have an inspection report,
  - d) the sender uses the special electronic posting list specified by Magyar Posta to dispatch the mail items, whose technical specifications are provided by Magyar Posta according to the date and the way agreed on with the sender, before the beginning date stated in the separate agreement,
  - e) only details of mail items posted with the regional tariff feature on the special electronic posting list,
  - f) the number of mail items posted are given for each postcode on the posting list; the zone classification for postcodes is available on Magyar Posta's web site at [www.posta.hu/level/vallalkozasoknak/tomeges\\_feladas](http://www.posta.hu/level/vallalkozasoknak/tomeges_feladas)
  - g) the mail items are physically separated from the other items according to zones based on their address and those which are not listed according to zones are sorted in different groups, and their handover occurs using this separation and grouping upon pick-up/dispatch,
  - h) the sender posts the mail items only at the National Logistics Centre.

When establishing the amount accepted, the quantities of priority and non-priority mail items arriving with one pick-up (for dispatch at one time, on one or more posting list(s) appearing on the same customer code) which belong to the same weight category but are sorted into different zones based on their address can be combined.

The quantities of mail items not sorted into zones based on their address cannot be combined with quantities of mail items sorted into zones, and such mail items will be accepted for postal handling and invoiced at the unit price for zone 4.

The tariffs in the tables below may be applied if all the conditions for applying the tariff listed in this point are complied with.
